Motion by Atchison to approve the minutes of the June 24, 2009 meeting as presented. Supported by Jones.

<u>Motion</u> by Jones that nominations be closed and a unanimous vote cast for Hramiec. Supported by Atchison.

Motion carried in a unanimous voice vote.

Committee Minutes:

Atchison commented that in the past the Committee, and he stated that he shared the blame, had been very remiss in having the meetings formalized by having minutes taken. He expressed his feeling that with all the activity in the community it was imperative minutes be taken and saved.

Transportation Committee History:

Atchison provided a recap of the recent history of the Transportation Committee and of the Community Transportation Outreach Program established by the County. He then summarized the overall position taken by the County.

Petitions:

Atchison provided a recap concerning petitions that had been requested. It was noted that the Committee did not believe that an "advisory" petition could be put on the ballot. There is not a Countywide general election this year. A special election would cost between thirty and forty-thousand dollars. A public body cannot support a millage proposal or spend money to advertise support of a millage proposal.

The Committee discussed the question of what might, if anything, be funded, how it would be funded, and how the Committee and County would define such a program.

The Committee requested Atkins to attend the upcoming Friends Enhancing Emmet Transit (F.E.E.T.) meeting and report back to the Committee.
